Her book adds substantive insight into the role of the social worker in advocacy by identifying the legal aspects of social work practice. Opposing a climate of pessimism, her discussion of the restoration and preservation of rights to housing, minimum standards of health and welfare, education, family preservation, and voting—along with constitutional protection of personal freedom—offers encouragement to advocates for homeless clients.

*The Civil Rights of Homeless People* identifies the legal issues in all social policy arenas, so that it can serve as a social policy text for teaching policy formulation and implementation. Goal oriented, it includes legal issues and strategies for effective collaboration in support of rights of homeless clients.
